

- establish and support new Chairs and research centres to provide leadership in different subject areas and boost the Faculty's external, postgraduate and research profiles.

The late John Haigh QC was a key member of the Law School's Campaign Committee and Paul East QC pays tribute to his work below. We also note the contribution made to the Law Faculty by Bill Williams who was our Media and Communications Adviser for many years. John and Paul will be greatly missed.
